


Installation Instructions **MKS4000 Vacuum Magnet Mount Kit**



IMPORTANT! Read all instructions before installing and using. Installer: This manual must be delivered to the end user.

WARNING!

Do not install and/or operate this safety product unless you have read and understand the safety information contained in this manual.

- 1. Proper installation combined with operator training in the use, care, and maintenance of emergency warning devices are essential to ensure the safety of you and those you are trying to protect.Exercise caution when working with live electrical connections.
- This product must be properly grounded. Inadequate grounding and/or shorting of electrical connections can cause high current arcing, which can cause personal injury and/or severe vehicle damage, including fire.
- 4. Proper placement and installation are vital to the performance of this warning device. Install this product so that output performance of the system is maximized and the controls are placed within convenient reach of the operator so that s/he can operate the system without losing eye contact with the roadway.
- It is the responsibility of the vehicle operator to ensure during use that all features of this product work correctly. In use, the vehicle operator should ensure the projection of the warning signal is not blocked by vehicle components (i.e., open trunks)
- or compartment doors), people, vehicles, or other obstructions.

MOUNTING:

Maximum recommended vehicle speed for safe operation using the Vacuum Mount model is 65 mph (104 km/h), when fitted to the center of a vehicle roof of steel construction. Higher speeds could cause the mount to fail, resulting in the minibar flying off of the vehicle, which could cause damage to other vehicles, and injury or death to the passengers.

The vacuum-magnet mount is not intended as a permanent mounting for the minibar. The vacuum-magnet mount unit must be mounted on a flat smooth magnetic surface (i.e. no fiberglass, ribbed style roofs, etc.). Insure that the magnet is kept clean.

Flange Mount:

- Prepare lighter adapter cord for safety light product wires with wire stripper. Disconnect beacon power and wait five (5) minutes. Join safety light product wires to cord with butt splices and crimping pliers. Connect positive (red) lighter adapter wire to positive safety light product wire. Connect negative (black) lighter adapter wire to negative safety light product wire. Check safety light product for proper voltage.
- 2. Stuff butt splice connections into center hole of flangemount light base. Route lighter adapter cord through strain relief on black plastic adapter plate.
- Align and place flange-mount light base upon black plastic adapter plate. Ensure three (3) holes in flange-mount light base align with three (3) holes in plate. Ensure lighter adapter cord is routed through strain relief in plate. Attach and tighten flange-mount light base to plate with three (3) plastic thread cutting screws.
- 4. Place safety light product at appropriate location to provide maximum signal effectiveness. Mounting surface must be a ferrous metal. Mounting surface must be clean and free of debris.
- 5. Plug lighter adapter cord into vehicle's lighter outlet. Check beacon for proper operation before using vehicle.

J-Bolt Mount:

- Prepare lighter adapter cord for safety light product wires with wire stripper. Route cord through center hole in flush/pipe mount adapter. Disconnect beacon power and wait five (5) minutes. Join beacon wires to cord with butt splices and crimping pliers. Connect positive (red) lighter adapter wire to positive safety light product wire. Connect negative (black) lighter adapter wire to negative safety light product wire. Check safety light product for proper voltage.
- 2. Align and place flush/pipe mount adapter upon black plastic adapter plate. Ensure four (4) holes in adapter align with four (4) holes in plate. Ensure lighter adapter cord is routed through strain relief in plate. Attach and tighten adapter to adapter plate with four (4) plastic thread cutting screws (included).
- Align and place J-bolt beacon upon flush/pipe mount adapter. Position and align four (4) J-bolt mounting holes in side of safety light product base with four (4) 5/32" adapter mounting holes in adapter. Secure safety light product to adapter and tighten four (4) adapter mount screws (not included; see adapter hardware kit).
- 4. Place safety light product at appropriate location to provide maximum signal effectiveness. Mounting surface must be a ferrous metal. Mounting surface must be clean and free of debris.
- 5. Plug lighter adapter cord into vehicle's lighter outlet. Check beacon for proper operation before using vehicle.

Manufacturer Limited Warranty and Limitation of Liability:
